The Circuit Courts have their name because early in the nation's history, the judges of the first courts of appeals visited each of the courts in one region in a particular sequence, traveling by horseback and riding "circuit." These courts of appeals review matters from the district courts of their geographical regions in the U.S. and from certain federal administrative agencies. A disappointed party in a district court usually has the right to have the case reviewed in the court of appeals for the circuit.

The judges who sit on the courts of appeals are appointed for life by the President with the advice and consent of the Senate. The judge who has served on the court the longest and who is under 65 years of age is designated as the chief judge, and performs administrative duties in addition to hearing cases. The chief judge serves for a maximum term of seven years.

The fees included in the Court of Appeals Miscellaneous Fee Schedule are to be charged for services provided by the courts of appeals.

- The United States should not be charged fees under this schedule, except as prescribed in Items 2, 4, and 5 when the information requested is available through remote electronic access.
- Federal agencies or programs that are funded from judiciary appropriations (agencies, organizations, and individuals providing services authorized by the Criminal Justice Act, 18 U.S.C. § 3006A, and bankruptcy administrators) should not be charged any fees under this schedule.
- (1) For docketing a case on appeal or review, or docketing any other proceeding, \$500.
 - Each party filing a notice of appeal pays a separate fee to the district court, but parties filing a joint notice of appeal pay only one fee.
 - There is no docketing fee for an application for an interlocutory appeal under 28 U.S.C. § 1292(b) or other petition for permission to appeal under Fed. R. App. P. 5, unless the appeal is allowed.

- There is no docketing fee for a direct bankruptcy appeal or a direct bankruptcy cross appeal, when the fee has been collected by the bankruptcy court in accordance with item 14 of the Bankruptcy Court Miscellaneous Fee Schedule.
- This fee is collected in addition to the statutory fee of \$5 that is collected under 28 U.S.C. § 1917.
- (2) For conducting a search of the court of appeals records, \$30 per name or item searched. This fee applies to services rendered on behalf of the United States if the information requested is available through remote electronic access.
 - (3) For certification of any document, \$11.
- (4) For reproducing any document, \$.50 per page. This fee applies to services rendered on behalf of the United States if the document requested is available through remote electronic access.
- (5) For reproducing recordings of proceedings, regardless of the medium, \$30, including the cost of materials. This fee applies to services rendered on behalf of the United States if the recording is available through remote electronic access
- (6) For reproducing the record in any appeal in which the court of appeals does not require an appendix pursuant to Fed. R. App. P. 30(f), \$83.
- (7) For retrieval of one box of records from a Federal Records Center, National Archives, or other storage location removed from the place of business of the court, \$64. For retrievals involving multiple boxes, \$39 for each additional box.
 - (8) For any payment returned or denied for insufficient funds, \$53.
- (9) For copies of opinions, a fee commensurate with the cost of printing, as fixed by each court.
- (10) For copies of the local rules of court, a fee commensurate with the cost of distributing the copies. The court may also distribute copies of the local rules without charge.
 - (11) For filing:

- Any separate or joint notice of appeal or application for appeal from the Bankruptcy Appellate Panel, \$5
- A notice of the allowance of an appeal from the Bankruptcy Appellate Panel, \$5.
- (12) For counsel's requested use of the court's videoconferencing equipment in connection with each oral argument, the court may charge and collect a fee of \$200 per remote location.
- (13) For original admission of attorney to practice, including a certificate of admission, \$176. For a duplicate certificate of admission or certificate of good standing, \$18.

Suggestions to Lawyers

On Briefs:

"The brief is extremely important. That is particularly true before the Third Circuit because we don't hear oral

argument in every case that is appealed, and it's important that the briefs really outline the issues so that in deciding if we are going to call for oral argument we really understand the significance of the case." In cases not determined by binding Supreme Court precedent, Roth said "precedent that isn't binding can be persuasive, [for example], precedent from other circuits and state courts."

She also looks for "reference to law review articles . . . and then just an explanation of why it's sensible and logical [and] beneficial to society as a whole to decide a case [in favor of the attorney's position]. I think legislative history can be significant, too. I am not of the [U.S. Supreme Court Justice Antonin] Scalia school that it should be shunned by all means. I think you have got to understand what legislative history is and how it's made up in order to draw the appropriate conclusions. So I think it can be helpful.

"The thing that bothers me the most is trying to hide an issue. Almost inevitably, you figure out what it is and that detracts very strongly from the credibility of the attorney who is making the argument. If you've got a problem with your case, acknowledge it, set it out and then persuade the court that it should still decide in your favor rather than try to hide it under the carpet." On Arguments:

"Because we don't have oral argument in every case, we don't want to hear a recitation of what the case is all about. Every judge has read all the briefs. We know what's in the briefs, we know what the facts are. We're having argument to try to explore beyond what's in the briefs. "If an attorney wants to avoid questions, [she or he should think about what areas the court may want to further explore and start with the statement of the most important issue and why it is the most significant. "An attorney arguing an appeal has to be ready to listen to the questions, to answer the questions and to leave the formal structure of any prepared argument and talk with the panel of judges about what the issues are." Roth said she is proactive in asking questions, ready to jump in at the beginning of the argument. "Sometimes a question is to help them rather than to

hurt them. Listen to the question carefully, because sometimes a [question is asked] to strengthen a point that an advocate is making." Roth said that, in addition to asking questions to satisfy her own concerns, she may ask questions that will move her fellow panelists to consider areas she considers important.

"Don't duck the question." In fighting the premise of a question, the best tactic, in Roth's opinion, is to first answer the direct inquiry, then to suggest a "more pragmatic, logical, helpful way to look at the issue." "Take the court beyond the question to [the attorney's] viewpoint of the issue involved. Don't say 'Your honor, I'm going to come to that in a minute, so wait.' Deal with it right away."
